A. BASIS OF ACCOUNTING AND PREPARATION OF FINANCIAL STATEMENTS:

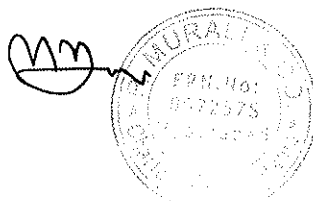

G. EARNINGS PER SHARE:

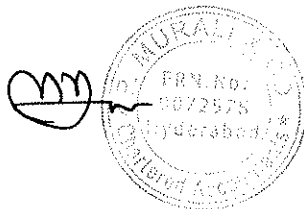
