Service Provider for E-Voting:

Pursuant to Regulation 44 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 and other applicable regulations, if any, including any statutory modification(s) or re-enactment(s) thereof for the time being in force the Company has arranged for remote e-voting facility to its shareholders through Central Depository Services (India) Limited (CDSL), (the "Agency").

The e-voting period commenced on Friday, September 26, 2025 at 09.00 A.M. (IST) and ended on Monday, September 29, 2025 at 05.00 P.M. (IST). The Agency e-voting platform [www.evotingindia.com] was blocked thereafter and the votes cast under e-voting facility were then unblocked by me on Tuesday, September 30, 2025 at 01:52 P.M. (IST) in presence of Mr. Trinath and Mr. Govind, two witnesses not being in the employment of the Company.
